FOR HIS CHILDREN (FHC) IS A CHRISTIAN MINISTRY THAT FUNDS A RESIDENTIAL CARE PROGRAM IN ECUADOR FOR VULNERABLE CHILDREN. FHC'S FUNDING PROVIDES RESIDENTIAL CARE, WHICH INCLUDES, MEDICAL CARE, EDUCATION, PHYSICAL THERAPY, LEGAL SERVICES, PSYCHOLOGICAL CARE AND SPIRITUAL SUPPORT. SINCE ITS FOUNDING IN 1990, APPROXIMATELY 650 CHILDREN HAVE BEEN CARED FOR AT FHC.

FHC PROVIDES FUNDING AND PROGRAM OVERSIGHT TO THE ECUADORIAN ENTITY "CORPORACION PARA SUS NINOS", WHICH CARRIES OUT THE MISSION OF CARING FOR CHILDREN IN AT-RISK OR VULNERABLE SITUATIONS. THE ORGANIZATIONS ARE NOT LEGALLY RELATED; HOWEVER, TWO BOARD MEMBERS SERVE BOTH ENTITIES.
