THE HOME IN LATACUNGA ALSO HOUSES THE "HOUSE OF HOPE" PROGRAM WHICH PROVIDES SPECIALIZED CARE FOR OLDER CHILDREN AND YOUNG ADULTS WITH SEVERE SPECIAL NEEDS WHO HAVE NOT BEEN ADOPTED BECAUSE OF THEIR DISABILITIES.
